



# Old Fletton Primary School Publication Scheme on information available under the Freedom of Information Act 2000

*The governing body is responsible for maintenance of this scheme.*

## **1. Introduction: what a publication scheme is and why it has been developed**

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- The classes of information which we publish or intend to publish;
- The manner in which the information will be published; and
- Whether the information is available free of charge or on payment.

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme is either available for you on our website to download and print off or available in paper form.

Some information which we hold may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner (updated 2013).

## **2. Aims and Objectives**

The school aims for learners at Old Fletton to:

- Will feel safe, confident and supported to embrace challenges.
- Do their very best - be proud of their achievements and celebrate the achievements of others.
- Be motivated and excited by their learning.
- Be well-prepared to take full advantage of the next stage in their learning and in life.
- Be able to make informed, thoughtful choices to help them become caring citizens and contribute positively to society.
- Recognise their own uniqueness and respect the uniqueness of others.

and this publication scheme is a means of showing you how to find the information which tells you how we are pursuing these aims.

## **3. Categories of information published**

This publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as 'classes'. These are contained in section 6 of this scheme.

The sort of information that we undertake to make available is organised into broad topic areas:

- Governors' Documents - including statement of Behaviour Principles, SEND report, Governors' strategy etc.
- Pupils & Curriculum – information about policies that relate to pupils and the school curriculum.
- School Policies and other information related to the school - information about policies that relate to the school in general.

Accessibility Plans	Plan for increasing participation of disabled pupils in the school's curriculum, improving the accessibility of the physical environment and improving delivery of information to disabled pupils
Safeguarding & Child Protection Policy	Statement of policy safeguarding and promoting welfare of pupils at the school. <i>(from March 2004)</i>

Pupil Behaviour & Expectations	Statement of general principles on behaviour and discipline and of measures taken by the head teacher to prevent bullying.

Published reports of Ofsted referring expressly to the school	Published report of the last inspection of the school and the summary of report and where appropriate inspection reports of religious education in those schools designated as having a religious character

School session times and term dates	Details of school session and dates of school terms and holidays

Complaints procedure	Statement of procedures for dealing with complaints
Performance Management of Staff	Statement of procedures adopted by the governing body relating to the performance management of staff and the annual report of the head teacher on the effectiveness of appraisal procedures - in Governor's minutes, available upon request
Staff Conduct, Discipline and Grievance	Statement of procedure for regulating conduct and discipline of school staff and procedures by which staff may seek redress for grievance
Curriculum circulars and statutory instruments	Any statutory instruments, departmental circulars and administrative memoranda sent by the Department of Education and Skills to the head teacher or governing body relating to the curriculum (see National Curriculum website)
